- I. **Welcome and Introductions:** Mr. Craig Kinley welcomed everyone to the meeting.
- II. **Call to Order:** The meeting was called to order at 12:03 p.m.
- III. **Quorum Validation:** A quorum was validated.
- IV. **Minutes Approval\* (November 15, 2022, and February 28, 2023):** Both sets of minutes were approved as submitted.
- V. **PY23 Youth Program Procurement Update (Ms. Eva Anagnostis, GCWDB Assistant Director):**  
Ms. Anagnostis shared all the activity that has taken place on the Youth Request for Proposals (RFP) process since our last meeting. Two proposals were submitted, and our Evaluation Team (comprised of Craig Kinley, Nita Donald, and Jared Mogan) scored both proposals. Eckerd Youth Alternatives received the highest score. Based on these scores, the GCWDB Executive Committee then voted to select Eckerd as our PY23 Youth provider.
- VI. **Director's Report (Mr. Dean E. Jones, GCWDB Executive Director)**
  - a. **PY23 3<sup>rd</sup> Quarter Performance Update:** Mr. Jones discussed recent 3<sup>rd</sup> Quarter performance reports that were released. We are currently not passing our Overall Indicator Score for Median Earnings, which is falling under 90%. Our records indicate that we should pass when 4<sup>th</sup> Quarter data comes in.
  - b. **Financial Status Report:** Mr. Jones shared financial performance information. Our Fund Utilization rates and Obligation rates are currently on track for the end of the year. Our In-School Youth expenditures are at 14%. Mr. Jones also shared the recent waiver that was approved at the state level to allow for In-School Youth expenditures up to 50% (raised from 25% normally allowed).
  - c. **PY23 Monitoring Updates:** We completed our local monitoring and state monitoring over the last few months. For local monitoring, Board staff are required to audit records from our contractors each year. Both contractors did well during monitoring. The issues we found

were very minor and easily corrected. State staff from SC Department of Employment and Workforce (SCDEW) completed our state monitoring virtually. They gave our staff and contractors compliments on how well our records are maintained and how we run our programs. No major issues were disclosed to us, but we will wait until we get the formal letter. Finally, the US Department of Labor is doing monitoring in SC this year, and they have decided to look specifically at Greenville.

- d. **Youth Program Training and Employment Guidance Letter (TEGL) 09-22:** Mr. Jones discussed a recent TEGL that was released that talks about different services for Youth. One of the services mentioned was Adult Mentoring for Youth. This is a required Youth Element, but few participants are using it nationally. We are going to look at ways to increase the use of Adult Mentoring in Greenville. Mr. Jones shared a possible idea to connect with other local organizations that are already offering mentoring, and potentially offer to pay a stipend to mentors to compensate them for their time. Chair Kinley suggested we connect with Dan Weidenbenner at Mill Village.

#### **VII. Contractor Update (Ms. Amanda Mason, Eckerd Connects Program Manager)**

Ms. Mason let the Committee know that this would be her last meeting, as she has accepted employment somewhere else. She then described some of the activities that are currently underway in the Youth Program. There are currently 78 enrollments for the year, and they are on track to meet enrollment goals for the program year. Since July 1, 15 individuals have graduated with their high school diploma or GED. There have been 17 on-site Work Experiences, 7 virtual Work Experiences, and 4 On-the-Job Training contracts for the year. The Youth program is continuing to build partnerships with Lifelong Learning and Greenville Literacy Association to serve individuals seeking a GED.

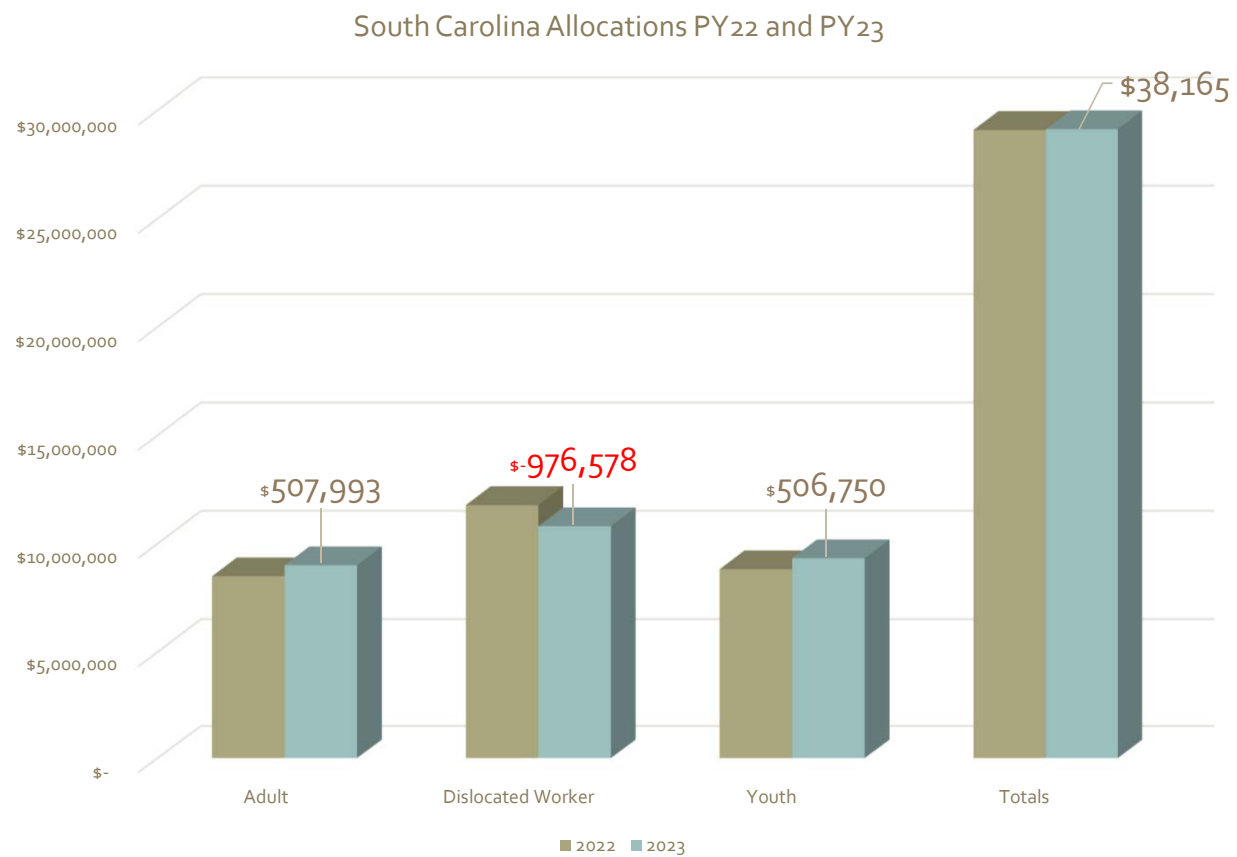

**Change 1 Revision:** To provide updated guidance regarding Title I Youth funds and activities and eligibility procedures, including updates to the following:

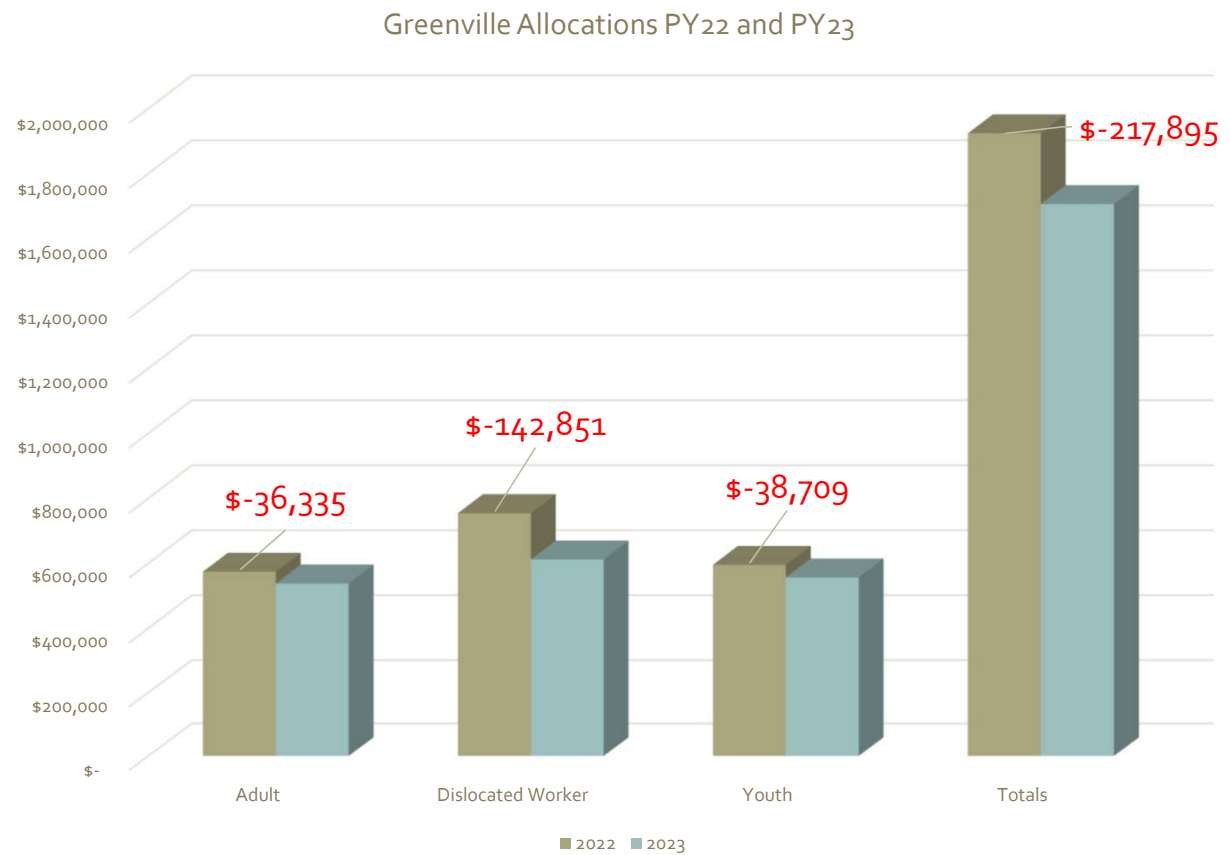
- LWDBs may allow use of assessments older than six months for basic skills deficiency determinations if appropriate.
- Self-Attestation Requirements
- Out-of-School Youth Expenditure Requirement Waiver for Program Years 2022 and 2023
- Work Experiences
  - Registered Apprenticeships are a type of work experience.
  - Virtual work experiences are allowable under the WIOA Youth program.
  - Work experience costs can include supportive services.
- Other Expenditures
  - Subject to certain limitations, supportive services may include food.
  - WIOA funds may be expended for devices and broadband internet access.

**DOL Announces the Creation of the Registered Apprenticeship Academy.** The U.S. Department of Labor's (DOL) Employment and Training Administration's Office of Apprenticeship has created the [Registered Apprenticeship Academy](#), which aims to provide top-notch information, training, and resources to all those involved around the work of Registered Apprenticeship. **DOL Awards \$11.7M to Help Organizations Prepare Young People for the Workforce in Underserved Communities.** The U.S. Department of Labor (DOL) announced the award of \$11.7 million in grants to three organizations to support programs that help youth and young adults in communities affected by violence and poverty to prepare for career success in the labor market. Administered by the department's Employment and Training Administration, these Growth Opportunities Intermediary grants focus on teenagers from 15 to 18 years old and young adults from 18 to 24 years old who are affected by community violence and poverty. Funding supports local organizations that provide occupational training and jobs to prepare these young people for workplace success. The grants will also help the organizations offer supportive services, including leadership development, mentoring and conflict-resolution skills. To view the press release, click [here](#).

**DOL Awards \$49.4M To 17 Organizations In 15 States to Provide Pre-, Post-Release Job Training, Services for Reentry Population.** The U.S. Department of Labor (DOL) announced the award of more than \$49.4 million in grants to 17 organizations in 15 states to provide training, employment and supportive services to adults reentering the workforce following incarceration in a local jail or state correctional facility. Administered by the department's [Employment and Training Administration](#), the Pathway Home grants aim to close the gap between an adult's release from incarceration and enrollment into a reentry program leading to employment. The grants will support efforts by local organizations to connect incarcerated people with providers of training and skills needed to obtain post-release jobs and comprehensive case management services to help them retain employment. **Biden-Harris Administration Announces State Allocations for \$42.45 Billion High-Speed Internet Grant Program as Part of Investing in America Agenda.** The Department of Commerce's National Telecommunications and Information Administration (NTIA) announced how it has allocated funding to all 50 states, the District of Columbia, and five territories to deploy affordable, reliable high-speed Internet service to everyone in America. This "Internet for All" initiative is a key component of President Biden's "Investing in America" agenda. States, D.C., and territories will use funding from the \$42.45 billion Broadband Equity, Access, and Deployment (BEAD) program from President Biden's Bipartisan Infrastructure Law to administer grant programs within their borders. The President, Vice President, and Secretary of Commerce Gina Raimondo announced the allocations at the White House. The BEAD funding will be used to deploy or upgrade broadband networks to ensure that everyone has access to reliable, affordable, high-speed Internet service. Once deployment goals are met, any remaining funding can be used to pursue eligible access-, adoption-, and equity-related uses. Under the Biden-Harris Administration's Internet for All Initiative, the Enabling Middle Mile Broadband Infrastructure Program invests in projects that build regional networks that connect to national Internet networks. Meanwhile business and industry are moving at the speed of light, and offering relevant, desirable, and outcomes-based training for new skilled trades that isn't always available through traditional means. That's why Indiana's new [career and technical education scholarship account program](#) (CSA) is a very cool, 21st Century idea. It gives students freedom to make those decisions outside of having to rely solely on what the system delivers. ### Delaware Workforce Development Board - Jobs for Delaware Graduates

**K'Zyiah**, a JDG BC DOL student attended Middletown High School and just graduated this past May. K'Zyiah expressed her interest in Pediatric Physical Therapy. She has always wanted to be a Physical Therapist and she loves children, so what better way to combine what she loves and aspires to be in her future. K'Zyiah was offered a paid work experience opportunity provided by JDG and immediately knew she wanted to work at a physical therapy office. She was also offered an internship at PIVOT Physical Therapy in Middletown, where she interned May 2022 until September 2022. K'Zyiah had expressed interest in college after her internship and would begin looking but did not have the resources or information to get enrolled. A student Outreach Coordinator offered guidance and transportation, and a week before classes began at Del Tech Community College, K'Zyiah was enrolled into the Physical Therapy program. She is now a full-time student and plans to transfer to a four-year college and receive her bachelor's degree. K'Zyiah is currently being assisted by JDG in finding a part or full-time job depending on her schedule at a Pediatric Physical Therapy office and possibly another paid work experience to assist her with her future career and education goals.

## WIOA Allocation Formulas

### Adult Funds

- 33⅓ percent based on the relative number of unemployed individuals in areas of substantial unemployment in each workforce development area, compared to the total number of unemployed individuals in areas of substantial unemployment in the State;
- 33⅓ percent based on the relative excess number of unemployed individuals in each workforce development area, compared to the total excess number of unemployed individuals in the State; and
- 33⅓ percent based on the relative number of disadvantaged adults in each workforce development area, compared to the total number of disadvantaged adults in the State.

### Youth Funds

- 33⅓ percent based on the relative number of unemployed individuals in areas of substantial unemployment in each workforce development area, compared to the total number of unemployed individuals in areas of substantial unemployment in the State;
- 33⅓ percent based on the relative excess number of unemployed individuals in each workforce development area, compared to the total excess number of unemployed individuals in the State; and
- 33⅓ percent based on the relative number of disadvantaged youth in each workforce development area, compared to the total number of disadvantaged youth in the State.

### Dislocated Worker Funds

The distribution formula is based on the following factors and weights:

- |   |     |

| • Declining Industries Data             | 5%  |

### Hold Harmless

- Applies to each funding stream. Ensures that funds are distributed without significant shifts in funding levels.
- A local area will not receive an allocation percentage that is less than 90 percent of the average allocation percentage of the local area for the 2 preceding years.
